July 2022 President's Report

Organizing and Political Activism

State Political Candidate Questionnaires -

The State AFL-CIO Committee on Political Education (COPE) met on Thursday, May 26th, 2022 at the Homer Maxey International Trade Resource Center. It was attended by myself, Irish, and Jeff NihipaliDay. Discussions ensued regarding the upcoming primary elections. What I've noticed at these meetings is that HGEA dominates much of the conversation. As a result, much of the decisions are made through the lens of HGEA's priorities and experiences. It's no surprise that, as they represent nearly 37000 members, which is nearly half of the AFL-CIO, they have close ties to state legislators who decide on the state budget. So it is understandable that they support the candidates that they feel will advance their interests. We have the power and ability to endorse the candidates that we feel will advance our interests.

Encore university - National negotiations continue with Encore. I've recently been invited to a meeting of the minds of Locals that are stakeholders in the conversation. At the moment, meetings are scheduled monthly. I will update the membership as details emerge.

Set visit - DKMD Fri, 07/15

HIFA - Met with Dexter Gomes and Koki Nishitani via Zoom to discuss the ongoing uphill battle to renew the HIFA program. There is a glimmer of hope, but we'll have to see how it pans out. I'll be reaching out to the West Coast office to ask them to support the HIFA program in whatever form it takes.

It's important to get active this election cycle. Our voices are powerful when we activate them. Voting in local political elections has a wide range of effects on our daily lives. Here are a few resources that will be helpful:

Training and Development -

District 2 - I was again selected as the chair of the D2 Young Workers Committee. Committee assignments are just that - assignments. Committee members and chairs are selected based on the District 2 Constitution and Bylaws. And though I've expressed several times that a younger delegate should be selected to chair the D2 YWC, it's still an honor to be selected as a committee chair from the more than 250 delegates. The majority of the committee members were from Local 839, The Animation Guild, with only one each from Local 80 and Local 728.

In a bit of a surprise, I was also asked to give the invocation. I had originally planned on doing a poem, but ultimately, it was more important to be in the moment. With the "Supreme" Court's decision to overturn Roe v Wade, I thought of my family - my wife, my daughter, my siblings. I thought of my co-workers, my union kin, and everyone capable of bearing a child. I've said it before and I'll say it again - I am so grateful to be a father. There is so much joy in my life because of my child and my wife. And I have room in my heart for as many children as my wife will give me. But it is her right to choose if and when she has that child.

Reproductive rights issues are workers rights issues. They are human rights issues. It's our job to fight for each other and use our power to protect those who are under duress. And we will do everything in our power to ensure that we do just that.

Several resolutions have been referred to the DEI committee specifically #'s 5, 11, and 16, which deal with employer sponsored implicit bias training, "Together we Shine" initiative, and Anti-ageism respectively. The DEI committee will be giving a report at the 2022 Midsummer GEB in Seattle. Our next committee meeting is scheduled for early August, and I will share the results of the resolutions discussion at the following meeting

We were invited by Local 16 to march with them in the SF Pride parade. The sheer number of people was staggering. Several of us attempted to join the march, but as you can imagine, the streets were blocked off for several miles. We attempted multiple times to reach the rendezvous point by crossing underground through the BART stations to no avail. So for a span of time, Chris Wiecking, Shawn Christensen, a delegate from Local 33 named Anthony Sacks, and I just cheered on from the sidelines. When the IA banner became visible, we walked with them up the street until we found a gap in the barricades. And so, we jumped the fence to break into the SF Pride march, a bucket list item that I didn't know I had.

Music Supervisors -

An overwhelming majority of film and tv Music Supervisors signed union authorization cards to form a union and become part of the International Alliance of Theatrical Stage Employees (IATSE). However, the major Hollywood studios and streaming companies indicated they will not voluntarily recognize, and will not begin negotiations.
